




LITTLE JOHN PARK IMPROVEMENT PROJECT

The City of Richmond has a goal of providing city parks within a ten minute walk of all Richmonders. In addition to creating new parks, the city has secured funding sources like the American Rescue Plan Act to improve existing parks. Little John Park, the strip of land across from the houses on Little John Road, qualifies as meeting the ten-minute pledge for the Sherwood Park neighborhood and has been identified for improvements in the FY2025 budget.

The Sherwood Park Civic Association is looking for neighborhood input on what amenities, infrastructure, landscaping, and vision they see for this space. Residents will have additional opportunities to provide input to Richmond Parks and Recreation when they conduct community engagement later this year. The SPCA understands that the ARPA funds must be committed by the end of 2024 and that the city is looking to build in 2025.

HERMITAGE /LABURNUM INTERSECTION RE-DO CHOICES REMAIN CONTROVERSIAL

The City of Richmond Department of Public Works, Traffic Engineering, hosted a follow-up open house on September 4 to educate the public and to gather feedback about the selected alternative designs. While removal of the A.P. Hill monument has reportedly reduced traffic accident by 71%, the city is committed to the Vision Zero goal of zero fatal accidents. Six alternative designs were presented with city staff providing explanations and facilitating discussions to small groups of northsiders. Handouts were provided with the results of the public survey.

While the survey indicated that the most popular design is the roundabout with north and southbound slip lanes,

an additional roundabout design and a protected intersection design with protected left turns were the next most popular. One surprise element is that a temporary solution is planned to begin installation as early as late November 2024.

At the open house, people continued to express concerns about pedestrian and bicycle safety, as well as about the safety of roundabout designs. Concern has been expressed about a potential disconnect between traffic engineering and the planners of the Hermitage segment of the Fall Line Trail. SHALOM FARMS CPR/AED CLASS FOR A CAUSE

Shalom Farms would like to place an AED (Automated External Defibrillator) machine on its Northside farm site. This would be

available for anyone in the neighborhood to use during an emergency — folks using the park and walking path, passing through, or visiting the farm.

Together with another nonprofit, Compression and Shock, Shalom Farms is offering a bystander CPR/AED course on the farm on Sunday, October 20 from 1-2:30pm. This will be free to the public and anyone over 13 years old can participate and learn some life-saving first aid skills. This is NOT a certification course. If they get a group of at least 35 people, an on-site AED will be donated.



Update from the Government Affairs/Safety Committee

The Quality Inn Hotel redevelopment by TRG

In the past 12 months we've had several meetings with City Council, Planning, DPW, and Economic Development to determine the impact of new residents at that site and how additional traffic will affect the surrounding neighborhood, particularly on Hermitage, Wentbridge and Little John. We've sent letters expressing our questions, requests and concerns and we continue to lobby to get more information as this redevelopment moves forward. A specific request has been made that a dedicated Traffic Impact Analysis(TIA) report be conducted at the five-spoke intersection adjacent to this site. There was a Diamond District Traffic Impact Analysis study conducted that incorporated the five-spoke intersection, yet did not take into consideration the redevelopment of the Quality Inn property. An additional study is still warranted but not yet funded.

Fall Line Trail

Based on previous plans presented we expect to have the FLT route through our neighborhood. As of now, what the route will look like to us is still to be determined. It is mentioned in the Diamond District Traffic Impact Analysis but is not conclusive. We are monitoring this closely and will continue to petition for more information.

Intersection of Loxley and Brookland Parkway

This is an intersection of safety concern for cars, bikes, and pedestrians. We anticipate working with DPW's Lighter, Quicker, Cheaper team to determine if there is a viable, safer solution for this intersection.

On certain issues, we have begun to coordinate our efforts with other Third District Civic Associations, in the interest of leveraging desired results. An example of this was the support we provided for the Mayoral, Third District and RPS forums held in September.

Our committee currently has 16 members and we welcome anyone that would like to join us. We have multiple issues on some of the above-mentioned projects that can use additional support. We are also looking for your input on new items for the committee.

CANDIDATE FORUMS

Turn-out was impressive at the Mayoral and City Council/School Board candidate forums this month. The two events came together thanks to a coalition of 3rd District neighborhood associations, initiated by Grady Hart of Rosedale Civic Association.

Approximately 150 people attended the Mayoral forum (despite being on the same night as the Presidential debate!) along with 30 online attendees. Eighty people attended the Council/School Board forum, while around 125 people watched online. We are awaiting a recording of the Mayoral forum.
